## GENERAL PROVISIONS

1. The port charges, other fees, and any amendments to these, levied by AS Saarte Liinid (hereinafter referred to as the 'port authority'), are established by AS Saarte Liinid. Changes to the charges will be announced to all parties operating in the port via the company's website at [www.saarteliinid.ee](http://www.saarteliinid.ee) or by other means.
2. The charges set out in this price list are collected either by the port operator or by the service provider specified in the price list.
3. VAT is added to the charges in accordance with applicable legislation.
4. The payment deadline for port charges levied by the port operator is generally 7 calendar days from the date of invoice. If a different deadline is agreed upon in a contract or other document with the recipient of the invoice, the agreed-upon deadline applies. The port operator is entitled to charge a penalty of 0.15% per day on the overdue amount for each day of delayed payment.
5. In the case of extraordinary maritime cargo, the port dues shall be calculated on the basis of special estimates, considering the measurements of the cargo, its load on port facilities, hazards to the port and additional expenditures.
6. The port operator reserves the right to change the amount of charges specified in the price list. In general, charges are adjusted once a year, on 1 January.
7. For contracts and written agreements lasting longer than one year, charges are generally adjusted based on the consumer price index (CPI), unless otherwise agreed.
8. The calculation of charges set out in this price list is based on the port rules and the ability to provide the service.
9. Disputes arising from this document that cannot be resolved by agreement will be settled under the legislation of the Republic of Estonia at the Kuressaare Courthouse of the Pärnu County Court.

## PART I. PORT CHARGES FOR VESSELS

### 1. FERRIES AND LINERS

For the carriers, selected by the state as a result of the public procurement, serving regular public ferry lines between mainland Estonia and the islands, and between the islands, the valid port service prices are determined by AS Saarte Liinid on the basis of the tender prepared for the public procurement, and this may differ from the prices provided in this price list. In order to submit a tender for participating in public procurement for ferry lines, the carrier must contact AS Saarte Liinid and provide all the information necessary to service the vessel used on the regular line.

**AS Saarte Liinid signs a contract for the provision of port services with the carrier declared as successful in the public procurement based on the tender.**

The contract for the provision of port services concluded with the carrier specifies:

- Basic port charges or port dues for liners listed in a separate agreement
- Passenger charge
- Waste charge
- Charge for loading/unloading cargo
- Conditions for the reception of bilge water, wastewater and garbage.

**Unless otherwise stipulated in the contract, the carrier pays for power supply, water and other port services according to the actual consumption of the period based on the price list.**



## 2. CARGO SHIPS, FISHING VESSELS, PASSENGER AND CRUISE SHIPS AND OTHER CRAFT

### 2.1. Tonnage fees and quay fees for cargo ships, passenger ships and other ships

\*January, February, March, December a special price of €1.35 is applied when calculating the tonnage fee.

- If the same cargo ship is loaded after unloading, a tonnage fee of 1.5 times is applied.
- The cargo ship quay fee is not applied from 2 hours before loading/unloading, during loading/unloading and up to 2 hours after completion of loading/unloading.
- The port has the right not to apply the quay fee for the cargo ship due to the logistical situation of the port.

### 2.2. Charges for fishing vessels

#### 2.2.1. Port charges for fishing vessels (except Virtsu Port)

- The port due for fishing vessels consists of a monthly fee and a quay fee, which takes into account the hours spent in the port during the calendar month.
- When calculating the quay fee, the time is rounded up to full hours.

#### 2.2.2. Port dues for fishing vessels in Virtsu Port

- The port due for fishing vessels in Virtsu Port includes a visit fee and quay fee for loading/unloading fish for up to 2 hours.
- The quay fee is applied when the fishing vessel stays in the Virtsu Port for more than 2 hours.
- When calculating the quay fee, the time is rounded up to full hours.

- Waste charge is charged separately for each visit.

\*\* Includes small (up to 300 W) electricity consumption, in the case of higher electricity consumption, an additional charge is agreed upon according to clause 4 of the price list.

- From the sixth person on board, €3 per person is added.
- The berth fee for catamarans and other large water craft is 1.5 times the price indicated in the price list.
- The berth fee for guests includes: berthing place, fresh water, use of toilet, use of shower and reception of sorted non-hazardous waste.
- The season fee includes a slip fee.
- The berth fee does not include the fee for electricity consumption.
- A standing time of more than 5 hours is considered a day.
- The water craft season fee does not include vehicle and/or trailer parking in the port territory.
- As a rule, water craft up to 5 m long and with up to 15 hp engine power are stored in the shore area or in sheds. Storage at the berthing place is only possible if there are free berths in agreement with the port manager and for a season fee of 70 euros (includes), while the fee does not include fresh water, electricity and use of shower. If the owner of the water craft wishes to ensure the fixed berthing place for the entire season, the discount will not be applied, and the fee will be calculated on the basis of the price list (water craft up to 5.99 m).
- Landing of water craft is only allowed in the shore area indicated in the Port Rules.
- The season is considered to be the navigation period of the calendar year from May 1 to October 31. Storage of water craft in the port waters outside of season is only possible by agreement with the port manager.



### 3.2. Charges for recreational craft making commercial trips (up to 12 passengers)

- The berth fee and charges for other port services are applied based on the price list, according to the actual consumption.
- The price includes the cost of embarking/ disembarkation of up to 12 passengers.
- For owners of the Saarte Liinid client card (SL ports in season), the visit fee for recreational craft making commercial trips is included in the cost of the client card.

### 3.3. Specifications in the price list for the Naissaare Harbour

Considering the fact that the Naissaare Island is not connected to the mainland electricity grid, the prices of Naissaare Harbour services differ from other AS Saarte Liinid ports. **Free standing time** is not applied in Naissaare Harbour.

- The berth fee for recreational craft in Naissaare Harbour includes:
  - **Berthing place, fresh water, use of toilet, use of shower and reception of non-hazardous waste.**
- The season fee for recreational craft in Naissaare Harbour includes:
  - **Berthing place, fresh water, use of toilet and reception of non-hazardous waste.**
- The berth fee also applies during the off-season, but no additional services are offered during this time.

#### 3.3.1 Seasonal berth fee in Naissaare Harbour (includes VAT):

- A written contract is concluded between AS Saarte Liinid and the user for the use of the seasonal berthing place.
- The season is considered to be the navigation period of the calendar year from May 1 to October 31.

- Landing of a personal water craft / water scooter is allowed at the shore area specified in the port rules.

### 4. POWER SUPPLY (charge added to the purchase price at resale)

The basis of the electricity resale price in the ports of AS Saarte Liinid is its purchase price according to the supplier's price list in force, to which a charge shall be added to cover the costs of the maintenance and operation of electrical equipment, and connecting and disconnecting the power system.

- Parking fee includes the right to park one specific vehicle.
- Permanent residents of small islands with permanent settlements are entitled to a 50% discount on parking fees for the calendar year (January 1 – December 31) in the parking areas of the respective small island ports and at the respective port parking areas on the mainland or large islands, based on the lists issued by the small island's local government."

- The captain of the vessel or their agent must order a tugboat 3 (three) hours prior to the start of the work and specify the order 1 (one) hour in advance. In the case of shorter notice, the call fee of €350 call is applied.
- All fees are calculated with an accuracy of 0.5 hours. A period of less than 30 minutes is considered 0.5 hours and more than 30 minutes is considered 1 hour.
- The prices of special works and works in other ports are carried out on the basis of separate agreements.

## PART IV. DISCOUNTS AND SPECIAL CONDITIONS

1. The charges of the services and port dues of contracted customers may differ from the product in the price list. In the absence of a contract, customers pay port dues in accordance with the provisions of this price list.
2. Water craft which have entered the port to deliver sick or deceased persons or shipwreck survivors shall be exempt from payment of the port dues, if they do not stay in the port for more than 24 hours.
3. For loading/unloading operations or embarkation and disembarkation of passengers in roadstead a fee of 25% of the port dues is charged. No road fee is charged in the case where a vessel is waiting for a loading/unloading operation or port formalities.
4. In the case of regattas and other sea sports events, discounted prices are applied in ports, up to 50% of the rates indicated in the price list.
5. The prices not set in the price list and special price list of ports shall be approved by the decisions and contracts of the management board of AS Saarte Liinid.
