## Part I. Port charges on vessels

### 1. FERRIES AND LINERS

For the carriers, servicing public regular ferry lines between the mainland and West-Estonian islands and who are identified by the Estonian Ministry of Economic Affairs and Communications as a result of public procurement, prices for port services are fixed by Saarte Liinid Ltd based on price offers made for the abovementioned public procurement and they may differ from current Price List. For acquiring the price offer required to participate in the public procurements for ferry lines, a carrier shall apply to Saarte Liinid Ltd and provide all necessary details for servicing the vessel to be used for a regular line.

**Saarte Liinid Ltd shall conclude a contract based on the issued price offer on providing port services with the carrier becoming the winning tenderer at public procurement.**

The contract on providing port services shall include:

- Basic port dues or port charges for liners listed in a separate agreement
- Passenger fee
- Waste fee
- Fee for loading/unloading goods
- Conditions for the reception of bilge water, wastewater and garbage.

**If not stipulated otherwise in the contract, carriers shall pay for power supply, fresh water and other port services according to the actual consumption during a period and the valid price list.**

### 2. CARGO SHIPS, FISHING VESSELS, PASSENGER AND CRUISE SHIPS AND OTHER CRAFT

#### 2.1 Charges for cargo ships, passenger and cruise ships and other craft

- If the same cargo ship is loaded after unloading, the tonnage fee is applied 1.5 times.

#### 2.2 Charges for fishing vessels

##### 2.2.1 Port dues (except Virtsu Port)

- The port dues for fishing vessels consists of a monthly fee and a quay fee, which takes into account the time spent in port during the calendar month, in hours.
- When calculating the quay fee, the time is rounded up to full hours.

- The port dues for fishing vessels in Virtsu Port include a visit fee and quay fee for loading/unloading fish for up to 2 hours.
- The quay fee is applied when the fishing vessel is in the port of Virtsu for more than 2 hours.
- When calculating the quay fee, the time is rounded up to full hours.

- The waste fee includes the reception of up to 1 m<sup>3</sup> of sorted waste and up to 1 ton of bilge water.

- For power supply, fresh water, waste and other port services, cargo ships shall be charged according to the actual consumption of services and of this price list.
- In case of extraordinary maritime cargo, the port dues shall be calculated on the basis of special estimates, considering the measurements of the cargo, its load on port facilities, hazards to the port and additional expenditures.
- The shipowners acting in state interest and/or functions of the Republic of Estonia (Transport Administration, Police and Border Guard Board, Eesti Loots AS., Environmental Board etc.), shall be charged the port dues in accordance with the contracts between them and Saarte Liinid Ltd. If the contract has not concluded, the possessors of the abovementioned vessels shall be charged according to the provisions of this price list.

- The berth charge for catamarans and other large water craft is 1.5 times the price indicated in the price list.
- Berth charge for guest includes: berthing place, fresh water, power supply, use of toilet, use of shower and reception of sorted waste. The berth charge for home port water craft does not include the fee for electricity consumption.
- Standing time of more than 8 hours is considered a day
- The berth charge does not include the parking fee for any vehicle at the port territory. Payment for parking is made according to the procedure and price applied in the specific port.
- As a discount, the seasonal home port fee for a water craft up to 5 m in length and up to 25 kW engine power is 50 euros (including 20% VAT). This discounted home port fee does not include the use of fresh water, electricity and shower.
  - As a rule, water craft up to 5 m in length are stored in the shore area, storage at the berthing place is possible only if there are vacancies and by agreement with the port manager.
  - If the owner of the water craft wishes to ensure the fixed berthing place for the entire season, the discount will not be applied, and the fee will be calculated on the basis of the price list (watercraft up to 6 m).
- The navigation season shall be the period from 1 May to 31 October.
- It is possible for water craft to stand in the port water area outside the season only in agreement with the port manager.

#### 3.2 Charges for recreational craft making commercial trips

- The berth fee and charges for other port services are applied based on the price list, according to the actual consumption.
- The visit fee includes the cost of embarking/ disembarkation up to 12 passengers. From 13 passengers, the passenger fee is applied on the basis of the price list.

### 3.3 Specificity of the price list in Naissaare harbour

Considering that Naissaare island does not have a connection to the mainland's power supply, the prices of Naissaare harbour services differ from other harbours of Saarte Liinid Ltd. **There is also no free of charge standing time in Naissaare harbour.**

- The berth fee and home port fee for recreational craft in Naissaare harbour includes:
  - **berthing place, fresh water, use of toilet, use of shower and reception of sorted waste.**

- Using of the seasonal berthing place is possible only after signing the contract with Saarte Liinid Ltd.
- The navigation season shall be the period from 1 May to 31 October.

- The ramp can be used only for loading/unloading the vehicles and cargo at the quay no 3.
- Landing of the personal watercraft / water scooter is allowed at the shore area specified in the port rules.

### 3.4 Berth fee for the water craft owned by residents of small-size islands

Permanent residents of the small-size islands (within the meaning of the Permanently Occupied Small Islands Act) have the right to apply for the use of one berthing place for a water craft up to 6 m in length free of charge for the season (01.05–31.10). An application accompanied by a residence permit issued by a local government must be presented in writing to the port's e-mail address or to the port overseer. Proof of residence must be issued less than 30 days from the date of application. Free berthing place does not apply if:

- there is at least one regular public transport connection from the port between a small island and a mainland or large island;
- a permanent resident of a small island provides commercial water craft services.

## Part II. Charges for port services

### 4. POWER SUPPLY (fee added to the purchase price at resale)

The basis of power resale price in the ports of Saarte Liinid Ltd is its purchase price according to the supplier's tariffs in force to which fee shall be added to cover the costs of the maintenance and operation of electrical equipment, connecting and disconnecting the power system.

- The price per 1m<sup>3</sup> of water sold to the resident population and companies is set by local government where the port is located. If the consumer is connected to the water supply system of a port, the subscription fee is added to the price of water.

- Parking procedures and pricing in Kuivastu, Virtsu, Heltermaa, Rohuküla ports shall be established separately.

Permanent residents of small islands are exempted from the parking fee in the parking areas of the respective small island ports and in the parking areas of the respective mainland or large island ports based on lists approved by the holder of parking area. (List of Registry plates of cars).

- The captain of the vessel or his agent shall be obliged to order a tugboat 3 (three) hours prior to the start of the work and specify the order 1 (one) hour in advance. In case of shorter notice, the call fee of 300 €/call will be applied.
- The price for the services of the tugboat PANDA shall be deemed to 0,5 hours. The service time less than 30 minutes is counted as 0,5 hours and more than 30 minutes is counted as 1,0 hours.
- Prices for special works and work in other ports are carried out based on separate agreements.

**14. USE OF PREMISES IN PORT BUILDINGS**

- The rental prices of the buildings, facilities and premises of Saarte Liinid Ltd shall be regulated by respective contracts.

**Part IV. Concessions and special conditions**

1. Prices and port charges for services provided to contract customers may differ from those set out in the price list. In the absence of a contract, customers shall be charged port dues in accordance with the provisions of this price list.
2. Water craft which have entered a port to deliver sick, shipwreck survivors of or deceased persons shall be exempt from payment of the port dues, if they do not stay in the port for more than 24 hours.
3. Military ships of the Republic of Estonia, NATO member states and other allies are exempted from port dues in the performance of their duties.

4. Loading/unloading operations or embarkation and disembarkation of passengers in roadstead a fee of 25% of the port dues shall be charged. No road fee shall be charged in case a vessel is waiting for a loading/unloading operation or port formalities.
5. Cruise ships shall be entitled to a 50% discount on the port dues.
6. In the case of regattas and other sea sports events, discounted prices are applied in ports, up to 50% of the rates indicated in the price list.
7. The prices not set in the price list and special price list of ports shall be approved by the decisions of the management board of Saarte Liinid Ltd.
